

# **Job Placement & Training**





# Natural Resources Department

Cama'i from the Natural Resources Department, and happy Spring!

There have been several new and interesting developments on the invasive species front, particularly regarding the population of invasive signal crayfish who have taken up residence in the Buskin Watershed.

At the upcoming Alaska Invasive Species Awareness Week (June 13th - 19th), "our" signal crayfish will be one of the featured species of concern for the entire State. Fortunately, signal crayfish have not invaded any other part of Alaska, but unfortunately they still remain a significant threat to the health and survival of salmon returning and rearing in the Buskin. We are hopeful that by being a featured species it will raise awareness and highlight the importance of protecting vital subsistence resources.

The Bureau of Indian Affairs has also continued its generous support of our programs designed to protect subsistence resources and increase opportunities for our Tribal Members to have an active role in natural resources management. We recently received a new grant from BIA's "Invasive Species Program" to spend the summer removing crayfish from the Buskin, as well as analyzing at least 550 of the crayfish we capture for carbon and nitrogen concentrations.

Carbon and nitrogen concentrations will help us understand what the crayfish are eating (the old saying of "you are what you eat" is very true in this case). Typically, more carbon (like carbohydrates) means you are eating more plants, while nitrogen (protein) indicates more animals. These concentrations will allow us to see what the main diet of crayfish is — more plants, more animals, or a mix — and therefore where they are "hanging out" on the food chain.

We'll also be analyzing a number of likely food resources eaten by crayfish for their own carbon and nitrogen concentrations to see if these foods have unique "signatures." One of the most-likely animals crayfish may be consuming in the Buskin (besides each other) are salmon, so if salmon have a unique signature, we'll be able to see if they are eating a lot of salmon... or just a little.

The funding from this grant is also creating more opportunities for our Tribal Youth Intern to gain excellent experience in resource management, ecology, and related fields of biological sciences. We are thrilled that Daniel Smith will be rejoining our team this summer, and he is enthusiastic to continue his studies and preparation to become a Wildlife Biologist — and to have a direct role in being a fellow steward of our natural world and protecting our subsistence resources.

Finally, another big element of this BIA grant is to increase education and outreach opportunities to the community and Tribal Members - so if any of you would like to participate and help us catch crayfish (especially on beautiful sunny days), let us know!

# **Tribal Transportation Program**

# **Road Safety Audit (RSA)**

Recently, STK received a BIA grant to perform a Roads Safety Audit (RSA) on our Tribal Roads Inventory. Despite Covid-19 circumstances, we were able to jump-start this project hiring a certified engineer to perform RSA required QA/QC which gives us a baseline analysis on 13 roads we selected at this time.

Purposes of the RSA is to assess the relative safety of the roadways and make recommendations for improvements. The RSA will review crash data and traffic volumes, review background reports and design criteria, and calculate crash rates and determine trends or "hot spots". Comprehensive field reviews are performed in the areas selected as through safety data analysis and/or from inherent knowledge of problem sites. STK will be working with both our City and Borough municipalities on this project.

Currently, STK is preparing a Tribal Safety Plan to include specific Road Safety Audit Findings and to execute priorities with our Partners.

# **Tribal Roads Safety Plan**

In 2005, the Federal Highway Administration and the Bureau of Indian Affairs, with Tribal input, developed a "Strategic Highway Safety Plan for Indian Lands". The Strategic Highway Safety Plan establishes direction and emphasis areas aimed at reducing crashes in Indian Country. In addition, in August 2008, the "Tribal Transportation Safety Management System Implementation Plan" was developed to improve safety and to meet emphasis areas identified in the "Strategic Highway Safety Plan for Indian Lands". STK received monies to develop a Tribal Roads Safety Plan.


#### **CURRENT AREA OF CONCERN**

In 2016, STK purchased a former cannery and dock which exists on a busy well-developed

waterfront corridor along Shelikof Street in downtown Kodiak. STK is currently converting the

property into a multi-use facility which includes a fish processing facility which is currently operational. Shelikof Street parallels the shoreline and the downtown boat harbor and hosts most of Kodiak's seafood processing plants with industrial and commercial businesses also occupying the road.

Shelikof Street is very busy and congested road due to lack of adequate parking. In addition, vehicles block walkways, heavy equipment operates in the ROW, and access to business is often blocked, forcing pedestrians into the roadway. STK is very concerned that this multi-use and congestion on Shelikof Street promotes potential incidents for injury and/or fatalities for both the public and workers. The Tribal Roads Safety Plan will address the road safety issues on Shelikof St. and will add more roads from the RSA to the Safety Plan.




Our people settled permanently where the city of Kodiak is now located about 2,500 years ago.

# Sun'aq Tribe of Kodiak Membership Dynamics


Alaska Members & Out of State Members
